Biographical Sketch

Annette Innis Young was born in Poughkeepsie, New York on January 1, 1885 - the first child of William Hopkins Young (1855-1909) and Martha Innis Young (1856-1946). Her father, William Young, was a prominent attorney who practiced in New York City. Her mother, the daughter of a wealthy and influential family, was a fixture in Poughkeepsie society.

Until she was ten years old Miss Young resided with her parents and her brother, Innis (1887-1953) at Rosewood, her grandparents' home at #40 Main Street in Poughkeepsie. In 1895 the family moved to Locust Grove, a large estate beautifully situated on the Hudson River just south of Poughkeepsie. The estate was designed in 1850-1851 for Samuel F.B. Morse, the artist and inventor of the telegraph, who spent summers at the estate until his death in 1872. Annette retained a lifelong interest in the gardens and the historic value of the estate as Samuel F.B. Morse's home.

Like many young women of her generation, Miss Young was educated at home by tutors and chose to live at Locust Grove for the rest of her life. As a child she learned French, Italian and German and continued to learn new languages, even trying to master Portuguese when she was in her 80's. She enjoyed sketching and painting especially her beloved horses and pets. She was also an accomplished equestrian, and enjoyed playing golf at the Dutchess Golf and Country Club (founded by her father) across the street from Locust Grove. For much of her life she was a member of St. John's Lutheran Church in Poughkeepsie.

Miss Young shared the duties of managing a number of historic family properties with her mother and brother, including the Innis family home (Rosewood, #40 Main Street, Poughkeepsie), the Locust Lawn farm in Gardiner, New York (built by Miss Young's Hasbrouck ancestors in 1814) and property in New York City. After her mother's death in 1946 and her brother's death in 1953, Annette became the sole custodian of the family legacy and she spent the rest of her life ensuring that her family's history would be preserved.

After Innis Young's death in 1953, Annette Young was the last surviving member of a family that had influenced Hudson Valley business, banking, and industry for six generations. She felt strongly that it was her responsibility to preserve her family legacy for, as she put it, "the benefit of those who come after."

Annette devoted her life to various charitable organizations, prominent among which was the Gallaudet Home for the Deaf, the Dutchess County Association for Prevention of Cruelty to Animals, the Old Ladies Home, the American Bible Society, Colonial Dames of New York State, Daughters of the American Revolution and the Dutchess County Historical Society. She was a life member of the Audubon Society

and Museum of Natural History. Annette's long interest in historic preservation included her support of the restoration of Huguenot Street in New Paltz. As a member of the Huguenot Society, she worked to preserve the Hasbrouck family home "Locust Lawn" in Gardiner, together with its family collections, as a museum.

In 1964 she orchestrated the designation of Locust Grove as a National Historic Landmark, and began preparations to open the house to the public as a museum.

In her will, she established a trust to maintain Locust Grove "in perpetuity as a historical site for the enjoyment, visitation and enlightenment of the public."

Annette died on October 15, 1975 and is buried in the Young family plot at the Poughkeepsie Rural Cemetery.

The executor of her will, Kenneth Hasbrouck, became the first President of the Board of Trustees of the Young-Morse Historic Site, which opened the Locust Grove property to the public beginning in 1979.

Scope and Content Note

The papers of Annette Innis Young are section of the larger Young Family Archives, which are in turn a component of the primary museum collection at Locust Grove. Miss Young grew up at the Locust Grove estate, and, upon her death in 1975 transferred all her personal property to found the museum. Her family papers were scattered throughout the mansion and outbuildings, and in the late 1970's an attempt was made by staff and volunteers to organize part of the Young Collection. This attempt was not systematic and, in fact, overlooked several hundred boxes of archival material which remained inaccessible until the late 1990's. Between 1998 and 2010, with partial funding from the New York State Archives through the Documentary Heritage Program, the Young Family Archives were removed from boxes, drawers and closets throughout the historic mansion and organized in a new storage facility in the Visitor Center to ensure their preservation and promote increased public access.

Annette Young's papers include correspondence, diaries, bills and receipts, cancelled checks, legal documents, insurance papers, tax records, and ephemera. Miss Young was convinced that her family's history was important and worth preserving, and she saved papers of every variety to document both her own life, and those of her relatives and ancestors.

While this collection is remarkable in its own right for its completeness, it also documents Annette Young's role in preserving the history and natural environment of the Hudson Valley. In her papers, major gifts of art to institutions like the Yale University Art Gallery, the Metropolitan Museum of Art, the Albany Institute of Art and History, and the Huguenot Historical Society are documented. The preservation of historic landscapes both at Locust Grove in Dutchess County, New York, and at Locust Lawn, in Ulster County, New York are particularly well documented.

In general, artificial series and arrangement groupings have been created, since no discernable order from the creator was evident. See the arrangement note for more information about arrangement by series.

Series Description

Series 1: Correspondence (1889-1976)

26 Boxes

Spanning the years from 1889 to 1975, Annette Young's correspondence consists of letters written to and from her family, friends and acquaintances as well numerous letters from her financial advisors, lawyers, doctors and bankers. The bulk of the correspondence consists of letters written to Annette since she made few copies of her outgoing correspondence.

Annette's correspondence is made up of letters and greeting cards filed in chronological order, followed by undated letters, empty envelopes, undated and unused greeting cards and unused stationery.

Annette's early correspondence consists mostly of letters and cards from her parents, her brother, Innis, and her extended family. Her later correspondence reveals her abiding interest and support of charitable organizations, both local and national. There is a great deal of correspondence concerning the day-to-day running and maintenance of her property at Locust Grove and at Locust Lawn, in Gardiner, Ulster County.

There are numerous letters from her brother, Innis Young, both from his home in New Haven, Connecticut and from abroad. He traveled widely and his letters are most informative, both of the countries he visited and the cultures he observed.

In 1943, Annette broke her leg and there is an individual box of get well cards to her. There is another box of condolence cards sent to Annette upon the death of her mother, Martha Young in 1946 and yet another box of condolence cards commiserating with Annette on the loss of her brother, Innis, who died in 1953.

Series 2:
Personal Papers

136 Boxes

Annette Innis Young's personal papers, like her correspondence, were part of the bequest she made in 1975 to found the museum at Locust Grove. They consist of a wide variety of materials arranged alphabetically by subject. Although Annette had attempted to make some order out of the myriad of papers and artifacts, unless otherwise noted, subject categories have been artificially created to improve access. The Personal Papers series includes the following major sub-series:

Bills, ranging from 1918 to 1975, are arranged chronologically. Many bills were arranged chronologically and alphabetically by Annette Young in expanding file folders. To improve their storage conditions, these files were transferred to new, acid free folders, and the original folders have been preserved separately in the collection. Bills cover a wide range of purchases and services including bills for contractors, utilities, pharmaceutical supplies, grocery and department stores, garages, garden and animal feed supply stores.

Cancelled Checks and Check Registers, from 1925 to 1975 are arranged chronologically.

Diaries dating from 1893 to 1973 are arranged chronologically.

Annette enjoyed sketching portraits of people and animals and many of these drawings are contained in the boxes labeled **Drawings** and **Scrapbooks**.

The **Estate of Annette Innis Young** consists of 16 boxes including the administration of the Estate, Probate and Legal Matters. There are voluminous papers concerning the litigation brought by the Estate of Annette Young against Earl J. Teed, et al. regarding property transfers at the end of Miss Young's life.

As Treasurer of **The Gallaudet Home**, the full name being The Gallaudet Home for Aged and Infirm Deaf Mutes, Annette spent a great deal of her time on this institution and amassed a large amount of paperwork. There are 4 boxes, the first of these boxes is separated out into subject matter. However, the other 3 boxes are labeled **Gallaudet Home, Van Gieson-Foster Papers** (for their apparent creator) that have not yet been arranged.

The **Kinkead Collection** is housed in one box and has not yet been arranged. The Kinkead Family were friends and neighbors of the Young Family and it is not known how these papers entered the Young Family Collection.

Taxes, from 1916 to 1975, include income taxes and Employee Pay Records from 1940 to 1975. Employees include the staff both at Locust Grove and at other family properties.

Annette was also Treasurer of the **Women's City Missionary Society**, an organization dedicated to aid the poor through donations of food, clothing and spiritual comfort. Included in this box are check book ledgers, pamphlets and financial reports.

Arrangement Note

In general, artificial categories have been created for the Young Family Archives in general and the Annette Innis Young Papers in particular. However, some overall trends present in the Young Archives were used as the basis for these categories.

Correspondence

Letters in the Young Family Archives were often grouped chronologically and so this arrangement protocol has been applied to the entire collection. Where large groups of letters were already organized (in the case of several boxes of get-well cards), the original boxes were retained as well. Ribbons tying bundles of letters have been retained in the collection, though the original bundles have been dismantled to facilitate access and preservation. In several instances, greeting cards were separated from general correspondence and continue to be housed in separate folders. Correspondence is not divided other than by year, and letters continue to be housed in their original envelopes (if they survive).

Personal Papers

In general, all categories in the Personal Papers sub-category have been artificially created. However, as with Correspondence, when a pattern of arrangement dating to the Young Family could be discerned it has been retained. Many Bills were organized chronologically and then alphabetically, often over a period of several years. All Bill folders arranged chronologically and alphabetically are original to the Young period. All bills arranged chronologically but not alphabetically have been sorted by the museum. Cancelled Checks have also been organized chronologically, as they were organized by the Young family. All other subject categories in Personal Papers have been artificially created by staff.

Maisie Terwillegar, housekeeper for the museum for many years, recalled in 2000 that Kenneth Hasbrouck, then the Board President, had destroyed some diaries and letters to protect Miss Young's reputation. It is not known how much material was lost.
